FALL MEETING

October 17, 2015

The Juniper Hill Ladies Golf Club met on Saturday, October 17, 2015, prior to our last 2015 event, The Haunting on the Hill. Thirty-Four (34) members were in attendance. Officers in attendance were Aggie Hampton, Co-Chair, Barbara Reynolds, Sec/Treasurer, Donna McNeil, Tournament Chair. Sue Wood was out of town.

The meeting was called to order by Co-Chair Aggie Hampton at 12:00 pm.

Aggie's first order of business was to ask the Secretary to read the minutes of the spring meeting and treasurer's report that was held on March, 2015. Copies of the minutes (and the treasurer's report) had been distributed to the members before the meeting began. Members requested that the minutes not be read. Barbara Reynolds gave a brief treasurer's report. Billie Robinson motioned that the minutes and treasurer's report be accepted and was seconded by Connie Wiard. Motion carried.

Donna McNeil, Tournament Chair, gave a report on her committee. She thanked all her committee volunteers for doing a great job. Aggie Hampton thanked Donna and her committee and all members in attendance were appreciative of this committee's hard work and especially for the Ladies Club Championship which was a big success. Donna's committee also took in more monies than expected due to sponsors and other donations, such as the left over skin money at the Governor's, and Kirk donating 20% of all beverage sales at the Governor's to the LCC. She estimates the balance in the Tournament account to be around \$1,100. The treasurer of the Tournament Committee, Pam Rhodes, will issue an official end of the year financial report soon and will be made available on the JHLGC website. This money will carry over and be used mostly for the 2016 LCC. Since there is a decent balance, the JHLC will not provide the \$200 start up fee for the 2016 season as we usually do. It was suggested and agreed that the tournament committee shall provide lunch (at the year end meeting) even if weather permits us not to play our final Haunting on the Hill event. Donna also discussed The Juniper Cup and it was agreed by all that it was a success and that next year there will be a few improvements made, such as a tournament where the team members actually play

together and instead of just 'bragging' rights, maybe some kind of award can be given. A motion was made by Tara Purvis to accept the Tournament Committee's report and seconded by Kim Wooldridge. Motion carried.

Kirk Schooley, our PGA professional, was introduced by Donna McNeil and presented a gift (a wine rack and 3 bottles of wine) as a token of our ladies appreciation for all that he does for the JHLGC. Aggie Hampton thanked Kirk for his support of the ladies leagues. Kirk thanked all the ladies for volunteering for helping the JHGA for all the hard work and desserts for the Governor's Open.

OLD BUSINESS

No old business was discussed.

NEW BUSINESS

Sue Wood, Donna McNeil and Aggie Hampton have been working on a new registration form for the 2016 season where members who join both leagues only write one check for dues/hdcp fees to the JHLGC and the treasurer would then reimburse the respective leagues their due's. This is a work in progress and will make the JHLC treasurer's job a bit more complicated and will hopefully be worked out before the beginning of the 2016 season. Barbara Reynolds contacted the KGA and asked if any increase was anticipated for next season. They were unable to give a definite answer, the next board meeting is scheduled for November 2015 and more information will be available then. Susan Goins suggested that if there is an increase of more than \$1, we would be required to raise our fees. Donna McNeil motioned that this be accepted and Connie Wiard seconded. Motion carried.

Teresa Prather brought up the discussion of how we can promote our ladies league(s) for the 2016 season. Teresa suggested that we put a generic sign/banner at the entrance of Juniper (that we can use annually) that reads something to the effect that "LADIES LEAGUE'S BEGINNING SOON" Inquire at Pro Shop or a telephone number. Prices for signage were 3 x6 \$42 and 4X8 \$60. More information is needed on the legalities of placing a sign at the entrance. Also discussed was giving an active member \$10 off on their membership if they recruit and sign up a new member, and post league info at work places. And how to promote the clinics and Golf 101 league more. Tara Purvis made the motion to purchase the sign and we would determine where it would be placed at a later date. PJ Johnson seconded the motion. Motion carried.
